7-13-20 1330 hrs.

The Township Parks Dept. reported signage at Netherwood Park was stolen sometime over the weekend.

They then all ran out of the store and into a waiting vehicle outside. As the vehicle left, two females fell out of the vehicle through the rear hatch which was open.
