4-16 19 1328 hrs.

Employees at the Bath and Body Works store in the mall reported three females were together inside the store. One of the females distracted an employee while the other two stole numerous items. Det. Devaney is following up.

4-17-19 1759 hrs.

Officers responded to the 400 block Glendale Cir. to investigate a disturbance and upon arrival observed a male arguing with another male. When approaching one of the males, Officers found one to be intoxicated and uncooperative. He refused to talk about what happened and took a fighting stance towards an officer. He attempted to strike an officer with his fist and was taken into custody. The male continued to act out by kicking the partition inside the police vehicle and yelling obscenities. Michael Mears 37 yrs. old from Springfield was charged with Aggravated Assault, Public Drunkenness, Disorderly Conduct among other charges and was held for arraignment.
