Press Release August 20, 2018

8-13-18 2217 hrs.

Ofc. Oswald observed a vehicle make a wide turn from Leamy Av. onto Orchard Rd. He observed the vehicle strike the curb two times on Orchard Rd. and stopped the vehicle on Lownes Ln. He found the operator of the vehicle, a 32 yr. old female from Springfield, intoxicated. She was taken into custody and asked to provide a blood sample. She was later released to family, and charges for DUI are pending.

8-13-18 2303 hrs.

Officers were called to 800 block Grove Av. to investigate a female who was walking around a property with a flashlight. Ofc. Annacone found Elizabeth Hartfield 35 yrs. old from Delaware in the area. She was found to be intoxicated and could not provide a valid reason for being in the area. Hartfield was taken into custody and transported to headquarters where she was charged with Disorderly Conduct and Public Drunkenness. She was held overnight before being released.
