

Press Release December 24, 2018

12-18-18 0225 hrs.

While on patrol, Ofc. Cutcliff observed a vehicle driving carelessly on the 900 block E. Woodland Av. Upon making contact with the driver, he found the driver to be under the influence of marijuana and located a quantity of marijuana on the driver floor area. The driver, a 20 yr. old male from Woodlyn, failed field sobriety tests and was taken into custody. He was released to family and will be charged with DUI.

12-18-18 2020 hrs.

Officers responded to the 800 block Garrett Ln. for a report of a fight in the street involving two male subjects. Upon arrival, they found four subjects loitering around a vehicle in the street. Two of the subjects had been involved in a physical altercation prior to police arrival. Two of the four subjects, an 18 yr. old from Philadelphia and an 18 yr. old from Springfield, were cited for Disorderly Conduct.

12-19-18 2355 hrs.

Ofc. Cutcliff found a vehicle travelling on the unit block E. Woodland Av. had a suspended registration for insurance cancellation. The vehicle was stopped, and the driver found to be under the influence of marijuana. Drug paraphernalia was found inside the vehicle. The driver, 29 yr. old male from Drexel Hill, was taken into custody and will be charged with DUI and Drug Offenses.

A customer at the Bed Bath and Beyond 800 block Baltimore Pk. reported a male and female had attempted to steal her wallet from her shopping cart. She said while walking around the store pushing a cart, a male and female walked close to her, and the male draped his coat over her cart and wallet. Both were held for arraignment and both are suspects in a similar theft reported one week prior.

He was also found to have an active arrest warrant from Delaware County for a Probation Violation and was transported to Delaware County Prison.
