6-5-18 0757 hrs.

Damage was found to the wooden railing securing the Old Central School building consisting of broken spindles. This damage occurred sometime during last weekend, and investigation revealed two males and three females had kicked the spindles breaking them off the railing. Det. Nutley was able to quickly identify all five juvenile suspects, unfortunately who are all Springfield residents, and will be continuing the investigation.

6-5-18 1220 hrs.

A resident of the 500 block Barry Dr. reported sometime between 11am and 12 am someone stole an Amazon package from his front porch.

6-5-18 1713 hrs.

Officers investigated a one vehicle crash on Springfield Rd. at Highland Rd. Investigation showed the driver of the vehicle intoxicated on Heroin. He was treated by Medical Personnel and submitted to a blood test at the hospital. Charges will be filed against the 52 yr. old male from West Chester.

6-6-18 1424 hrs.

A Florida woman who had just come from the airport enroute to visit family stopped at Chick Fil A and had her purse stolen from the back of a chair while she ate. Cash and credit cards were taken, and investigation showed the cards used at the Target Store soon after the theft. Det. McNeely is investigating.

6-6-18 1747 hrs.

A resident of the 400 block E. Woodland Av. reported a decorative Baltimore Ravens flag taken from outside his apartment. There are plenty of suspects.

6-6-18 1840 hrs.

Target at the mall security reported observing a male subject in the men's clothing department selecting items of clothing and placing them in a shopping cart. He then concealed the clothing in a bag and tried to leave without paying. Kamorrie Brown 29 yrs. old from Philadelphia was taken into custody and charged with Retail Theft. He was taken to Springfield Court for arraignment.

Officers responded to the Marriott Courtyard Hotel to investigate a disturbance involving a male and female staying at the hotel. The two were involved in a physical altercation in which the male was accused of pushing the female's head against the bathroom wall causing a laceration. As Officers made contact with the male, the male was belligerent, and used his chest to bump an Officer multiple times. The male was taken into custody and identified as Matthew Long 29 yrs. old from Havertown. He was charged with Disorderly Conduct, Resisting Arrest and other charges.

6-7-18 0729 hrs.

Officers responded to the Smashburger 400 block S. State Rd. to investigate a burglary. Employees reported that sometime overnight, someone entered the business through the rear door and removed a business safe from an office. Det. McNeely is investigating.

The department took reports from numerous people who reported their Franklin Mint Credit Union debit cards had been used without authorization and money was missing from their bank accounts. Preliminary investigation leads to a possibility that a skimmer device had been placed on the ATM at the branch on the 300 block Baltimore Pk. Detectives Devaney and Nutley are investigating. Please be aware of skimmer devices and businesses which use credit/debit card readers and report suspicious activities.
