6-10-19 1653 hrs.

A shopper at the Springfield Mall reported briefly leaving her cell phone on a massage chair by accident and went into a store. When she returned to the chair, the phone was gone. The victim called the phone, and a male answered demanding money for the phone to be returned. Det. Nutley is investigating.

6-12-19 0354 hrs.

Ryan Large 32 yrs. old from Pottstown was arrested for Public Drunkenness after being found passed out on the floor in the pharmacy area of CVS 300 block Baltimore Pk. He was found to be intoxicated and had walked to CVS after having an altercation with acquaintances at the Days Inn. He was held until sober.
