3-19-18 1200 hrs.

While on patrol, Officer Clifton stopped a vehicle for an equipment violation on the 300 block of Powell Rd. Three occupants were inside the vehicle, and a strong odor of burnt marijuana was present as well as a smoke condition. Investigation revealed a quantity of marijuana inside the vehicle along with drug paraphernalia. All three subjects were taken into custody. One adult from Clifton Heights was charged with drug offenses and held for arraignment. Two juveniles, one from Clifton Heights and one from Springfield, were released to family and charges will be filed.

3-19-18 1710 hrs.
