Press Release May 13, 2019

5-6-19 1910 hrs.

Officers responded to Target at the mall after security there reported having stopped a female for stealing jewelry and clothing. Officers found that a female had selected a quantity of jewelry and clothing from display racks and concealed the items in a handbag. She then tried to leave without paying and was stopped by security. Security located and recovered a bar-code reading device the woman had stolen. While in police custody, Officers located a quantity of illegal drugs in her possession. Jennifer Adkins 36 yrs. old from Boothwyn was charged with Retail Theft and Drug Offenses and held for arraignment.

5-6-19 2135 hrs.

Officers were called to the Parkway Inn 600 block Baltimore Pk. to investigate a domestic dispute. They found that a male and female were involved in an argument, and the male stole the females purse containing debit and credit cards and identification and left the area. The male shortly thereafter withdrew money from an ATM in the area. Officers located the male on the 400 block Baltimore Pk. and located the empty purse in the middle of the highway. The male had possession of the female's property, illegal narcotics, and was found to be armed with a handgun. Mark Dedmon 24 yrs. old from Collingdale was taken into custody and found to have an active arrest warrant out of Philadelphia for Assault. He was charged with Drug and Weapons offenses and held for court.

Officers went to the Days Inn 600 block Baltimore Pk. to assist a woman who was fighting with her boyfriend. The boyfriend left the property, and a short time later police were called back to the hotel by the woman who reported the male returned and stole her wallet containing cash and identification. Officers located the male walking on the 300 block Baltimore Pk. and stopped him. Officers recovered the stolen wallet and arrested the male. The male, Frank Artis 26 yrs. old from Philadelphia, was charged with Burglary and Theft and held for arraignment at Springfield Court.

Officers investigated a traffic crash in which a vehicle drove into a traffic light standard in the area of S. Bishop Av. and Springfield Rd. The driver was injured and needed medical assistance. He was found to be intoxicated and refused a blood test. The male, 41 yrs. old from Ridley Park, was treated at a hospital and will be charged with DUI.

Springfield Pasta Company reported a female entered the store and pulled two dinner plates from the refrigerated display cases and presented the items for return valued at \$25 after complaining of dissatisfaction to an employee.
