Press Release October 29, 2018

10-22-18 0711 hrs.

Officers responded to the Best Buy store 600 block Baltimore Pk. to investigate damage to the glass on an exterior door. They found someone had smashed the glass and entered the vestibule sometime overnight. The person was stymied at the interior doors however and nothing was stolen.

10-22-18 1441 hrs.

Target at the mall security reported having a female in custody for shoplifting. Officers responded and found the female had stolen 6 cans of baby formula, and on a previous occasion stole 12 cans of baby formula. The total value of both thefts was over \$300. Allyson McGinnes 20 yrs. old from Brookhaven was arrested and charged with Retail Theft. She was held for arraignment at Springfield Court.

10-22-18 2102 hrs.

Alisha Thomas 33 yrs. old from Drexel Hill was taken into custody and charged with Retail Theft after Target at the mall security watched her select 32 items of clothing and attempt to walk out of the store failing to pay for the items. She was held for arraignment at Springfield Court.

10-23-18 0306 hrs.

While on patrol, Ofc. Hurwitz found a smashed front door at the Casual Male store 200 block Baltimore Pk. Further investigation showed that someone had entered the store around 0045 hrs. and opened two cash registers and stole a quantity of jackets and sweaters. Investigation continuing.

Target at the mall security reported observing two females selecting numerous items of merchandise including toys, space heater, curtains, and towels and placing them in a shopping cart. They wheeled the cart to the self-service checkout area and rang up the same towel 9 times but forgot the other items. They then left the store with the cart.
