9-24-18 2107 hrs.

Target at the mall security reported having stopped a female for stealing \$490 worth of infant merchandise. Officers responded and took Briana Shelley 23 yrs. old from Philadelphia into custody. She was charged with Retail Theft and held for arraignment.

9-26-18 1325 hrs.
