9-3-18 1310 hrs.

A vehicle previously reported a stolen from the Springfield Mall 8-28 was recovered in Philadelphia by Philadelphia PD

9-4-18 1529 hrs.

The Wine and Spirits Store 100 block Baltimore Pk. reported a male entered the business on 9-1 and took a \$15 bottle of coconut rum from a display shelf. He left without paying.

9-5-18 2156 hrs.

Ofc. Cutcliff responded to the mall parking lot to investigate a subject who was reportedly trying to enter parked vehicles in the lot. He located a male subject in the lot who was highly intoxicated and just wanted a ride home. The male was given a ride to the police station and turned over to his mother. David Glenn 54 yrs. old from Wallingford was charged with Public Drunkenness.
