8-6-24 1150 hrs.

A member at LAFitness 800 block Baltimore Pk. reported a gym bag containing various Apple products and his wallet was stolen from a locker which had its lock cut. The victim tracked the stolen items to King of Prussia Mall, and Ofc. Walsh developed a suspect from surveillance video. On 8-7-24 Det. McNeely identified the suspect as Philip Sok 44 yrs. old from Philadelphia and observed him in the LAFitness parking lot entering a vehicle. He was taken into custody, charged with Theft and related offenses, and held for arraignment.
