1-27-26 1244 hrs.

Officers responded to the Target at the mall for a report that a male had stolen over \$117 worth of health and beauty products and fled. Officers located and identified the suspect on the trolley tracks near Thomson Av. Michael Foundos, 45 yrs. old from Philadelphia, was taken into custody and charged with Retail Theft and held for arraignment.

A resident of the 200 block E. Leamy Av. reported a drone was stolen from a work vehicle sometime overnight.

A 22 yr. old male from Havertown will be charged with Retail Theft after security at Target at the mall observed him steal close to \$300 worth of Legos.
