#### Weekly Press Blotter June 10, 2024

6-3-24 0826 hrs.

Officers were alerted to a reported stolen vehicle being operated on Baltimore Pk. near Saxer Av. and stopped the vehicle on the 700 block. The operator was identified as Daniel Harris, 22 yrs. old from Drexel Hill, and the vehicle Nissan Altima confirmed stolen from Philadelphia. Harris was taken into custody and charged with Receiving Stolen Property and held for arraignment.

6-4-24 1648 hrs.

Employees from the Giant Store 700 block W. Sproul Rd. reported a male had stolen an amount of merchandise and left the store. Responding officers located the suspect at a bus stop on Sproul Rd. and took him into custody and recovered the merchandise. The 42 yr. old will be charged with Retail Theft.

6-5-24 1400 hrs.

A vehicle being operated with illegal equipment was stopped on the unit block Baltimore Pk. The driver was a 23 yr. old male from Philadelphia. During the course of the stop, Officer Bergman recognized the presence of marijuana inside the vehicle, and the driver turned over two baggies of suspected marijuana. A further search of the vehicle was conducted, and over 1 lb of marijuana was seized. The investigation is continuing.

6-5-24 1742 hrs.

Officers were called to a house on the 400 block N. State Rd. for a report of two unwanted subjects inside the house. Upon arrival it was learned that two males who were performing replacement roof work went inside the house and removed several items including a firearm and a microwave oven. Officers located the suspects inside a work van which was leaving the area and stopped the males. Oscar Alvarez 36 yrs. old from Philadelphia and Rolando Ortiz 29 yrs. old from Philadelphia were taken into custody and charged with Burglary and related offenses and held for arraignment.

6-6-24 1854 hrs.

A resident of the 200 block Welsh Dr. reported the rear window to her vehicle smashed sometime between 1630 and 1850 hrs. by unknown means.

6-7-24 0149 hrs.

Officers assisted Marple PD in looking for a male who had threatened an employee of a business in Marple Twp. and fled in a vehicle. Springfield Officers observed the suspect who parked on the 600 block Buttonwood Dr. and barricaded himself inside a house. Members of the Central Delaware County Tactical Response Team conducted an operation and entered the house and took the male into custody. The male was turned over to Marple PD.

6-8-24 0305 hrs.

A 51 yr. old male from Brookhaven was arrested for DUI after officers were alerted to his vehicle by it being in a stolen vehicle database. The vehicle was stopped on State Rd. near Collins Dr., and the male was found to be intoxicated. It was learned the driver was in fact the owner of the vehicle. The male was taken into custody and submitted to a blood test. He was later released, and charges for DUI will be filed.

6-8-24 1833 hrs.

A 49 yr. old male from Springfield was taken into custody and will be charged with Public Drunkenness after being observed unconscious on a bench in the Springfield Shopping Center 700 block W. Sproul Rd. He was awoken and found to be intoxicated.

6-9-24 1658 hrs.

Officers responded to Target at the mall for a report that a male and female were wheeling shopping carts of merchandise outside failing to pay for what was loaded. Officers stopped the female, but the male fled and entered a vehicle in the lot. Close to \$500 worth of merchandise was recovered. The female, 25 yrs. old from Philadelphia, was taken into custody and found to have an arrest warrant from Montgomery County. She was turned over to Montgomery County Sheriffs, and charges for Retail Theft will be filed.
