5-30-23 1639 hrs.

Officers responded to the Target store at the mall for a report that a male had just stolen baby formula and walked out towards the rear of the property. Officers located the suspect and identified him at the trolley stop. Richard Catalano 27 yrs. old from Long Branch, NJ was taken into custody and charged with Retail Theft. He was arraigned and transported to Delaware County Prison.

5-30-23 1901 hrs.

While investigating a group of people loitering at Rolling Green Park it was found that one of their vehicles displayed a stolen license plate from Philadelphia. The subject driving attempted to leave the park with the vehicle and was stopped on Hempstead Rd. Marvin Rodriguez-Murcia 32 yrs. old from Philadelphia was taken into custody and charged with Receiving Stolen Property. He was held for arraignment.

6-1-23 0748 hrs.

A male and female were observed unconscious at the bus stop on the 1100 block Baltimore Pk.
