10-12-20 0613 hrs.

A resident of the 200 block Powell Rd. reported her vehicle was stolen from the street in front of her house.

On 10-13-20 at 1154 hrs. we were notified by the Harrisonburg, VA police who found the vehicle and a male subject nearby who was subsequently arrested. The male was in possession of a key to the vehicle. The male arrested had been identified earlier in the morning 10-12 on Baltimore Pk. in Springfield. Investigation is continuing.

10-12-20 2336 hrs.

Three unlocked vehicles were entered sometime during the evening; one on the 300 block E. Leamy Av. and two on the 100 block S. Rolling Rd. Nothing was reported missing.

As the females ran out of the store with the merchandise and to a waiting vehicle, one turned towards an employee and held up what appeared to be a stun gun.
