8-29-22 1322 hrs.

Officers were called to the Springfield Mall 1200 block Baltimore Pk. to investigate an assault. Four victims reported that an adult female assaulted them for no known reason using her hands and fled the mall going towards Sproul Rd. Two female victims were punched in the head and a male who attempted to intervene was bitten on his finger. Det. McCarthy is investigating.

CVS 700 block Baltimore Pk. reported the theft of razors and deodorant from the store, and the male suspect fled on foot. Responding officers located the suspect a block away and stopped him. He was identified as the thief and a 43 yr. old from Philadelphia. The merchandise was recovered. The male was processed and released, and charges for Retail Theft will be filed.
