3-3-25, 1353 hrs.

A resident from the 600 block of Prospect Rd reported a theft from his unlocked vehicle which was parked in the driveway. A black Calvin Klein jacket, \$10 cash and his US passport were taken.

3-3-25, 1400 hrs.

Target, 1200 Baltimore Pike, reported a female detained for theft.
