9-25-23, 1146 hrs.

Macy's, 1300 Baltimore Pike, reported a shoplifter in custody. Tanisha Williams, 30 years old from Upper Darby, was observed selecting merchandise and entering a fitting room. She left the fitting room carrying bags and security determined no items had been left behind in the room. Williams was apprehended by security as she was leaving the store. \$358 of unpaid merchandise was recovered. She was turned over to police and charged with Retail Theft.

9-26-23, 1559 hrs.

Target, 1200 Baltimore Pike, reported shoplifting in progress. Security provided a description of the suspect and a vehicle involved. Officers located the vehicle in the parking lot and recovered the stolen items. The suspect, Alvin Ellis Irving III, 47 years old from Philadelphia, was located exiting the store. \$254 of unpaid merchandise was recovered. Irving III was arrested and charged with Retail Theft.
