10-21-19, 2116 hrs.

A theft from vehicle occurred in the parking lot of Bertucci's, 965 Baltimore Pike. The victim discovered a window smashed in his 2015 Dodge Ram. Stolen was a backpack and wallet containing credit cards, work ID and cell phone. Det. Bridget McCarthy is investigating.
