Press Release April 29, 2019

4-22-19 1301 hrs.

Officers took a report from security at Target at the mall regarding a male subject who had stolen numerous cans of infant formula from display on multiple occasions the last few days totaling over \$1000. On 4-23 at about 0902 hrs. Officers observed this subject pushing a shopping cart containing over \$500 worth of infant formula in the parking lot outside the store after being contacted by Target security. The subject was stopped and identified as Kareem Jones 28 yrs. old from Chester. He was taken into custody and charged with multiple counts of Retail Theft and held for arraignment.

4-22-19 1308 hrs.

A resident of the 300 block Gibbons Rd. reported arriving home after being away for a few hours and finding her home had been forcibly entered through a rear window. A bedroom was ransacked, and an unknown quantity of jewelry was taken. Det. McNeely is investigating and reviewing surveillance video from the area.

4-22-19 2203 hrs.

An employee from Olive Garden 1000 block Baltimore Pk. reported someone had smashed her vehicle window while she worked and removed a pocketbook from the passenger floor area.

Officers were called to the Parkway Inn 600 block Baltimore Pk. to investigate an assault involving a male who had struck his girlfriend inside the room they were staying. The male fled before arrival of police but was later found in the rear of lot of a nearby business drunk, drinking beer and waiting to be arrested. Officers responded to Target at the mall and took into custody Quiera Benyard 24 yrs. old from Philadelphia after she walked out of the store pushing a shopping cart with over \$500 worth of stolen merchandise. She was charged with Retail Theft and held for arraignment.

While on patrol on the 600 block Saxer Av., a male subject walked in front of Officer Oswald's police vehicle and yelled obscenities at him. The male then walked to the driver side of the vehicle and said he wanted to fight but continued to walk towards Baltimore Pk. Officers stopped traffic, and the male verbally threatened to kill the officers. Officers took the subject into custody and found a quantity of drugs and drug paraphernalia in his possession. Jefferson Weiah 22 yrs. old from Phoenixville, formerly of Springfield, was charged with Aggravated Assault, Drug Offenses and other crimes and held for arraignment.
