12-2-19 1056 hrs.

A 51 yr. old male from Springfield will be cited for Disorderly Conduct after being observed on the Wawa property causing customers annoyance and alarm. This subject had been warned on prior occasions to cease his activity.

Target at the mall security reported they had investigated an employee for stealing numerous items of Apple and Nintendo products over a period of time. The subject was fired from his employment, and charges for Theft will be filed.
