6-11-18 1148 hrs.

A resident of the unit block of Saxer Av. reported that three newly planted bushes and a freshly trimmed tree along the property line had been sprayed with a substance that killed them and the grass around the area.

6-12-18 1302 hrs.

A landscaper had been cutting grass on the 300 block of Memorial Park Dr. and discovered a backpack blower had been taken from his truck.

6-12-18 1318 hrs.

Three males entered the AT&T store on the 700 block W. Sproul Rd., cut cords to two Samsung cell phones on display and removed the phones. They ran out of the store and left in a silver vehicle with a DE registration plate. Det. Devaney is investigating.
